As per the tax laws laid down in India, it is mandatory to file income tax returns if your income is more than the basic exemption limits i.e. Rs 2, 50,000. Tax returns have to be filed by an individual or a business on or before 31st July of the assessment year unless extended by the Income Tax Department. If a taxpayer fails to abide by the deadline, he or she has to pay a penalty.
